# New York City

**October 23-27, 2017**

DAY 1...Off you go to NYC with an early morning departure from Fort Wayne and Decatur. Travel to New York City area where you will check into your hotel. Meals will be on your own along the way.

DAY 2... Following breakfast at your hotel, board your motorcoach and travel into Manhattan to meet our local guide for a **Tour of Upper Manhattan** which will include the Lincoln Center, United Nations, Fifth Avenue, Harlem, St. John Divine Cathedral, Central Park and Rockefeller Center. Tour will end at **Rockefeller Center** where you will enjoy lunch on your own. Free time will give you time to visit **St. Patrick's Cathedral** and other area attractions. Later, you will enjoy a behind-the-scenes tour of **NBC Studios** where your favorite shows are made. Afterwards, depart for dinner (included). Your day will end with an outstanding **Broadway Show**. (Show will be determined at a later date.)

Day 3....Enjoy breakfast, then board our motorcoach and head for Battery Park at the lower end of Manhattan where you will board the Statue Cruises Ferry. Cruise to Liberty Island where you will visit the **Statue of Liberty**. The Statue was an international gift of friendship from the people of France to the people of the United States. Your enhanced visit will include an audio tour which will guide you through the unique history of Liberty Island from its time as a fort through the construction of the Statue of Liberty and its establishment as a national monument. After your visit, board the ferry and cruise to **Ellis Island**, a landmark which symbolizes America's immigrant heritage. The Museum is designed as a self-guided museum with three floors of audio/visual displays and exhibits detailing the history of the immigration process from 1912 to 1954. Your enhanced visit will include an audio tour through all three levels of the historic Main Building while allowing you to vividly relive the immigrant experience through first-hand immigration accounts. You will also have the opportunity to see the Wall of Honor which lists the names of immigrants that arrived on Ellis Island. Board the ferry to return to Battery Park. Proceed to the **One World Observatory** for a panoramic view of New York City and New Jersey. Afterwards, enjoy dinner at a local restaurant.

Day 4....We will have breakfast at hotel, then board our motorcoach and head to Manhattan to meet our guide for a **Tour of Lower Manhattan**. The tour includes the famous building and colorful districts such as Soho, Little Italy, Chinatown, the Garment District, the Financial District and Ground Zero. Enjoy lunch on your own. While in Lower Manhattan, you will visit the **9/11 Memorial Site** where you will have a guided tour of the **9/11 Memorial Museum** which serves as a national tribute of remembrance and honor to the men, women and children that were killed in the terror attacks of September 11, 2001. Dinner this evening will be included in Little Italy. Time to say "good by" to the Big Apple.

Day 5....Following breakfast, you will head home to Indiana with fond memories of your trip to the "the city that never sleeps".
