DAY 1...All Aboard!!! Overnight lodging in Missouri.

DAY 2....Arrive in Wichita, Kansas, and meet our guides and check into the Drury Inn. Rest and relax before departing for the Mid-America All Indian Museum for authentic dinner and entertainment. After dinner we will see Wichita's most photographed iconic attraction, Keeper of the Plains Statue, including the lighting of the cauldrons. B, D

DAY 3... Depart with guides to visit Greensburg, Kansas, site of the first recorded EF5 Tornado. Events will be shared leading up to the infamous 2007 storm which destroyed over 95 percent of the town. Learn how Greensburg rose from the debris and tragedy to recover and rebuild as one of first almost entirely green friendly cities powered by solar and wind. A visit to the Big Well Museum is included. The Museum features the largest hand-dug well in the US at 32 feet wide and 100 feet deep. Lunch is included. Depart back to Wichita to visit Old Cowtown. Visit the fun and interactive replica Old West restored and recreated town frozen in time from the days of the famous Chisolm Cattle Trail era 1865-1880. Learn the story of how Wichita went from a frontier settlement, to a cow town, to an agricultural and manufacturing area. Fifty-four historic sites on the Arkansas River bring to life this unique, education and fun site featuring costumed interpreters. Old Cowtown has been the location of many Hollywood Western movies as well. Back to Drury to enjoy complimentary drinks and their famous Kick Back dinner event every evening from 5:30-7 PM. Enjoy a stroll along the Riverwalk Parks nearby. B, L, D

DAY 4... Depart with guides to Wakita, Kansas, used in the filming of Twister! Visit the quaint <u>Twister Museum</u>, owned by storm chasers, and learn more about the filming of the movie along with lots of fun artifacts and props including the Dorothy weather instrument! Stop by the lot where Aunt Meg's house stood, and of course see the famous Wakita water tower! We will play the movie en route! Rogers is buried on the grounds which include artifacts, memorabilia, photographs, and more showcasing his amazing life and career! Next stop is the D-Bar Cattle Ranch for a delicious brisket lunch in the meadow before touring the 800-acre family owned and operated cattle ranch.
