Then, the Band of the Ceremonial Guard will provide music while the Guards are inspected and the Old Guard becomes the New Guard. The ceremony, modelled on one in London, England, dates back to 1959. Lunch on own. Next stop <u>Canadian Museum of History</u>...A national museum on Canadian history. Dinner on own. B
- **DAY 4...** Off we go to Quebec City with its European flavor, fashion & food. Mid-afternoon check into Hotel Chateau Laurier, Quebec City, great location near the Old City Walls.
